### **INTRODUCTION**:

A major component of the annual tourism marketing plan of the Convention & Visitors Bureau is a printed Visitor's Guide. Hundreds are mailed each year to fulfill guest's inquiries from around the Globe, while thousands more are distributed locally to highlight attractions, art & culture, shopping, dining, nightlife, lodging and recreation which promote the Joplin Experience as a tourism destination.

#### **SUMMARY:**

This Council Bill seeks permission from Council for the City Manager to sign an agreement with Publications Printers Corp. of Denver, CO. for the printing of the Convention & Visitors Bureau, 2018 Joplin Visitor's Guide. This agreement is for printing 60,000 copies of the 84-page guide. This printing and quantity support the bureau's marketing effort over an 18-month period.

This printer selection was made following the City of Joplin RFP process of which 13 providers submitted bids.

### **RECOMMENDATION:**

The Convention & Visitors Bureau recommends approval of this agreement as part of continued tourism marketing program and allow the City Manager to sign this agreement.

AN ORDINANCE approving an Agreement by and between the City of Joplin, Missouri and Publication Printers Corporation, a Colorado Corporation, in the amount of \$20,821.00 for the publication of 60,000 copies of the Convention & Visitors Bureau's 2018 Joplin Visitor's Guide; and authorizing the City Manager to execute said Agreement by and on behalf of the City of Joplin, Missouri; and amending the Annual Budget of the City of Joplin for the Fiscal Year 2017-2018 as adopted by Ordinance 2017-167 on October 16, 2017.

WHEREAS, the voters of the City of Joplin passed council bill 88-17 approving the creation of a 2% lodging tax on April 5, 1988, thus creating the Joplin Convention and Visitors Bureau; and,

WHEREAS, the use of these funds is to promote tourist, conventions and other related activities within the tourism region of the city; and,

WHEREAS, the Joplin Visitor's Guide is to highlight attractions, art & culture, shopping, dining, nightlife, lodging and recreation to promote the Joplin Experience as a tourism destination; and,

WHEREAS, after following the City's RFP process, the CVB selected the provider, and desires to utilize a portion of the proceeds from said tax.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY JOPLIN, MISSOURI, as follows:

Section 1. That the Agreement by and between the City of Joplin and Publication Printers Corporation, a Colorado Corporation, in the amount of \$20,821.00 for the publication of 60,000 copies of the Convention & Visitors Bureau's 2018 Joplin Visitor's Guide, a true and accurate copy of said Agreement being attached hereto and incorporated as "Exhibit "A," be and the same is hereby approved.

<u>Section 2</u>. That the City Manager of the City of Joplin, Missouri, is hereby authorized and directed to execute said agreement, or agreement in substantially similar form, by and on behalf of the City of Joplin.

<u>Section 3.</u> That fiscal year 2017-2018 budgeted appropriations as adopted by Ordinance 2017-167 be amended by increasing appropriations by the total amount of Fourteen Thousand Dollars and No Cents (\$14,000.00).

<u>Section 4.</u> That the Director of Finance is hereby directed to make all necessary entries on the City records to show the increase in appropriations.
