Recommended Action: Approval of Work Authorization Number JET DR-1 & DR-2 PAP 9-1 with Olsson Associates dba Joplin Joint Engineering Team for the not to exceed amount of One Million Four Hundred and Eighty-Two Thousand Two Hundred and Thirty-Seven and 00/100 Dollars (\$1,482,237.00) for Survey, Design, Bidding, and Construction Services for Sidewalk, Curb & Gutter, Street, and Storm Water Projects in the Recovery Area funded with Community Development Block Grant-Disaster Recovery funds.

Background: In 2013 the City of Joplin Council reviewed and approved the "Joplin Community Phase II Recovery Plan". City staff then worked with various consulting firms and contractors to complete many of the projects included in the plan approved by Council. Due to the large number of infrastructure projects and the scheduling challenges with environmental clearance, public involvement, construction coordination, etc. the City staff estimated the budgets conservatively to ensure completion of the projects ranked highest by City Council. It was anticipated that with the successful completion of various projects in the plan, funds that had been budgeted would become available for a continuation of the recovery plan by completing

more surface projects. City staff, City consultants, and our Contractors have completed many of the projects under budget and this has allowed a continuation of the original recovery plan projects.

Discussion: City staff directed the JET design team to prepare a scope of services for disaster recovery funded surface projects within the recovery area. The projects are all surface projects within the recovery area as shown on the attached map. The table on the following page shows the projects with the services and cost of services included in this work authorization. The overall program is on schedule to be completed before the Fall of 2019 which is the overall CDBG-DR expenditure deadline.

Recommendation: Staff recommends Approval of Work Authorization Number JET DR-1 & DR-2 PAP 9-1 with Olsson Associates dba Joplin Joint Engineering Team for the not to exceed amount of One Million Four Hundred and Eighty-Two Thousand Two Hundred and Thirty-Seven and 00/100 Dollars (\$1,482,237.00) for Survey, Design, Bidding, and Construction Services for Sidewalk, Curb & Gutter, Street, and Storm Water Projects in the Recovery Area be approved on an emergency basis per Section 2.12 (6) of the Joplin City Charter.
